#### 1. TERMS OF REFERENCE

- 1.1 Based on the Service Agreement (No.: VA1944), the Hong Kong Council for Accreditation of Academic and Vocational Qualifications (HKCAAVQ), in the capacity of the Accreditation Authority as provided for under the Accreditation of Academic and Vocational Qualifications Ordinance (Cap 592) (AAVQO), was commissioned by Kornerstone Limited (格納思通有限公司) ("Operator") to conduct a Learning Programme Re-accreditation (re-LPA) Exercise with the following Terms of Reference:
  - (a) To conduct an accreditation test as provided for in AAVQO to determine whether the following programmes of the Operator meet the stated objectives and Hong Kong Qualifications Framework (HKQF, or in short QF) Level 2 standard and can continue to be offered as accredited programmes:
    - (i) Foundation Certificate in Information Security Practices
    - (ii) Foundation Certificate in Human Resources Practices
    - (iii) Foundation Certificate in Financial Practices; and
    - (iv) Foundation Certificate in Project Practices
  - (b) To issue to the Operator an accreditation report setting out the results of the determination in relation to (a) by HKCAAVQ.
- 1.2 The accreditation exercise was conducted according to the relevant accreditation guidelines referred to in the Service Agreement. A site visit took place on 9 July 2025.

documents including comprehensive programme review records for FCISP, FCHRP, FCFP, and FCPP to HKCAAVQ by 31 July 2026:

- c) Summary of feedback collected from learner feedback survey for each programme;
- d) Post-course review reports from Trainers for each programme;
- e) Post-course review reports from Subject Experts for each programme;
- f) Meeting minutes of programme monitoring and review for each programme; and
- g) Records of follow-up actions taken after considering the post-course review reports in the programme review meeting

#### Recommendation 1

The Operator should require applicants to submit relevant documents in support of their academic qualifications and work experience and put in place a stringent admission procedure including but not limited to the verification of applicants' qualifications to ensure the admitted learners meet the stipulated admission requirement.

#### Recommendation 2

The Operator should include a detailed time allocation of each topic in the lesson plans of each programme to enhance the learning and teaching effectiveness and facilitate learners' attainment of intended learning outcomes.

2.15 HKCAAVQ will subsequently satisfy itself whether the Operator remains competent to achieve the relevant objectives and the Programme continues to meet the standard to achieve the relevant objectives as claimed by the Operator by reference to, amongst other things, the Operator's fulfilment of any conditions and compliance with any restrictions stipulated in this Accreditation Report. For the avoidance of doubt, maintenance of accreditation status is subject to fulfilment of any condition and compliance with any restriction stipulated in this Accreditation Report. During the validity period, HKCAAVQ may request the Operator to provide evidence, such as admission related information, to demonstrate that the Operator and the Programme continue to comply with the determinations and meet the relevant accreditation standards.

3.1 Kornerstone Limited, established in 2006, is a private training provider offering a variety of training programmes to individuals and corporate members, including cloud platform, cybersecurity and business management training etc. Following its merger with Trainocate Group in 2017, Kornerstone became a strategic partner and a subsidiary of the group.

#### 4. PROGRAMME DETAILS

# 4.1 Programme Objectives

## Foundation Certificate in Information Security Practices

This programme aims at enabling the participants to attain the foundation technical and managerial knowledge of information security which defines the architecture, design, management and controls that assure the security of business.

#### **Foundation Certificate in Human Resources Practices**

This programme aims at enabling the participants to have a basic understanding on general skills and practices in Human Resources (HR). It also provides practical cases in developing and executing HR tasks.

#### Foundation Certificate in Financial Practices

This programme aims at providing the participants with the latest financial risk concepts so that they could provide competent advice based on globally accepted industry standards and are committed to personal professional development.

## **Foundation Certificate in Project Practices**

The programme is dedicated to providing junior staff with a comprehensive training programme that covers the essential foundations of project practices. By equipping junior staff with the knowledge and skills required for proficient project practices,

this programme seeks to enhance their professional development and contribute to the success of their organisation as a whole.

# 4.4 Graduation Requirements

### **All Programmes**

- 1. Attained a minimum attendance requirement of 70%;
- 2. Written assignment (50% passing mark; 20% of overall);
- 3. In-class Participation (10% of overall)
- 4. Final examination (50% passing mark; 70% of overall);
- 5. Obtained a score of 50% or above in the overall assessment.

### 4.5 Admission Requirements

#### **All Programmes**

- (a) Completion of secondary school education; and
- (b) Attainment of Grade E or above in English Language (syllabus B) or Grade C or above in English Language (syllabus A) in HKCEE; Grade 2 or above in English Language in HKDSE; and
- (c) One year of working experience.

#### 5. IMPORTANT INFORMATION REGARDING THIS ACCREDITATION REPORT

### 5.1 Variation and withdrawal of this Accreditation Report

- 5.1.1 This Accreditation Report is issued pursuant to section 5 of the AAVQO, and contains HKCAAVQ's substantive determination regarding the accreditation, including the validity period as well as any conditions and restrictions subject to which the determination is to have effect.
- 5.1.2 HKCAAVQ may subsequently decide to vary or withdraw this Accreditation Report if it is satisfied that any of the grounds set out in section 5 (2) of the AAVQO apply. This includes where HKCAAVQ is satisfied that the Operator is no longer competent to achieve the relevant objectives and/or the Programme no longer meets the standard to achieve the relevant objectives as claimed by the Operator (whether by reference to the Operator's failure to fulfil any conditions and/or comply with any restrictions stipulated in this Accreditation Report or otherwise) or where at any time during the validity period there has/have been substantial change(s) introduced by the Operator after HKCAAVQ has issued the accreditation report(s) to the Operator and which has/have not been approved by HKCAAVQ. Please refer to the 'Guidance Notes on Substantial Change to Accreditation Status' in seeking approval for proposed changes. These Guidance Notes can be downloaded from the HKCAAVQ website.

- 5.1.3 If HKCAAVQ decides to vary or withdraw this Accreditation Report, it will give the Operator notice of such variation or withdrawal pursuant to section 5(4) of the AAVQO.
- 5.1.4 The accreditation status of the Operator and/or Programme will lapse immediately upon the expiry of the validity period or upon the issuance of a notice of withdrawal of this Accreditation Report.

# 5.2 Appeals

- 5.2.1 If the Operator is aggrieved by the determination made in this Accreditation Report, then pursuant to Part 3 of the AAVQO the Operator has a right of appeal to the Appeal Board. Any appeal must be lodged within 30 days of the receipt of this Accreditation Report.
- 5.2.2 If the Operator is aggrieved by a decision to vary or withdraw this Accreditation Report, then pursuant to Part 3 of the AAVQO the Operator has a right of appeal to the Appeal Board. Any appeal must be lodged within 30 days of the receipt of the Notice of Variation or Withdrawal.
- 5.2.3 The Operator should be aware that a notice of variation or withdrawal of this Accreditation Report is not itself an accreditation report and the right to appeal against HKCAAVQ's substantive determination regarding accreditation arises only from this Accreditation Report.

### 5.3 Qualifications Register

- 5.3.2 Only learners who commence the study of the named accredited learning programme during the validity period and who have graduated with the named qualification listed in the QR will be considered to have acquired a qualification recognised under the QF.
