SUMMARY ACCREDITATION REPORT

This accreditation report is issued by the Hong Kong Council for Accreditation of Academic and Vocational Qualifications (HKCAAVQ) in its capacity as the Accreditation Authority as provided for under the Accreditation of Academic and Vocational Qualifications Ordinance (Cap 592) (AAVQO). This report outlines the HKCAAVQ's determination, the validity period of the determination as well as any conditions or restrictions on the determination.

1. Introduction

1.1 Beacon (Evening) College (Mong Kok) [遵理夜校(旺角)] is one of the branches under the governance of the Board of Directors of Beacon College. It offers a wide variety of education programmes targeted at different age groups ranging from children to working adults.

1.2 Based on the Service Agreement, the HKCAAVQ was commissioned by the Beacon (Evening) College (Mong Kok) [遵理夜校(旺角)] (the Operator) to (a) conduct an Initial Evaluation exercise to ascertain and determine whether the Operator is competent to achieve its stated objectives and to operate learning programmes meeting Qualifications Framework (QF) standard at QF Levels 1 - 3 and (b) to assess and determine whether the following learning programme achieves the stated objectives and meets the QF standard at QF Level 3:

(1) Diploma of Business Communication

1.3 The accreditation exercise was conducted according to the relevant accreditation guidelines referred to in the Service Agreement as well as the Terms of Reference stated therein. An on-site visit took place on 24 October 2013.

3.1 Programme Objectives

The programme aims to help learners enhance the proficiency in English and strengthen business communication skills for a promising career in this highly competitive workforce in Hong Kong. The programme provides intensive training of the four language skills, speaking, listening, writing and reading as well as general language competence in terms of lexical items and structures.

3.2 Programme Intended Learning Outcomes

Upon completion of the Programme, learners should be able to:

- Develop a responsible and self-directed capability for quantity and quality of output in English in order to be able to select and use English to obtain, process and combine information;
- Access, organise and evaluate English activities to gain extending knowledge and experience different culture in order to be able to perform tasks in a wide range of familiar contexts;
- Understand both predictable and unpredictable spoken information, ideas, related explanations, discussion / argument and evaluation in familiar contexts;
- Interact socially in conversation using increasing complexity and length in a wide range of familiar contexts;
- Handle, understand and present predictable and unpredictable information via interaction

- in familiar contexts orally;
- Understand both predictable and unpredictable written information in different familiar contexts;
- Present information, ideas, related explanations, discussion/argument and evaluation in written form; and
- Apply various language skills and linguistic features in various familiar contexts.
